¡Viva Cancún! 2020 Limitless Worldwide Cancún Xperience Official Terms and Conditions

The 2020 Limitless "Viva Cancún" Xperience is designed to recognize and reward Limitless Distributors for certain business development activities. <u>Through point accumulation, Distributors may earn their</u> <u>vacation or earn a discount off the price of the vacation. Alternatively, Distributors may</u> <u>purchase the trip outright.</u> Airfare can be earned through an increase in Organizational Volume but is otherwise the Distributor and their guest's responsibility.
