



2021 Limitless Worldwide Hawaii Xperience Official Terms and Conditions

Join your Limitless family in the trip of a lifetime! **Through point accumulation, Distributors may earn their vacation or earn a discount off the price of the vacation. Alternatively, Distributors may purchase the trip outright.** Airfare can be earned through an increase in Organizational Volume but is otherwise the Distributor and their guest's responsibility.

Qualification Period: (12 commission months) May 1, 2020 - April 30, 2021

Reward: 5 Night Stay for 2 in Hawaii, August 2021 (Official dates to be announced)

Final Payment Deadline: May 5, 2021

Required deposits: To be eligible to begin earning points, or to purchase the vacation, a Distributor must declare their intent, by placing a NON-REFUNDABLE deposit. Deposits will be applied toward the vacation purchase price, or in the event the Distributor earns the trip outright, will be returned to the Distributor as a cash payment on the trip.

Existing Distributor Deposit: To be eligible to begin earning points, or to purchase the vacation, a Distributor must declare their intent, by placing a NON-REFUNDABLE deposit, no later than August 31, 2020.

Kick-Off Deposit Special: \$150 when deposit is made by June 30, 2020

Standard Deposit: \$250 when deposit is made July 1 - August 31, 2020

New Distributor Eligibility: (Distributors enrolled after June 30, 2020) New Distributors may declare their intent to earn or purchase the trip by placing a NON-REFUNDABLE deposit of \$150 within 30 days of their enrollment. Beyond 30 days of their enrollment, the standard deposit will be required.

Deposits for new Distributors must be received no later than November 1, 2020. Deposits received after August 31 are subject to room availability.

Vacation Value/Purchase Price: This vacation in paradise is valued at \$4,500. Discounts will be applied to this amount based on points earned during the qualification period.

2 Ways to earn Points: Personally sponsoring or reengaging Distributors (Team building activities), and sponsoring or re-engaging personal Customers (customer acquisition and maintenance).
