Limitless 2.0 Customer Acquisition Bonuses

Year 1: \$2,000 Year 2: \$5,000

The Customer Acquisition Bonuses are designed to help Distributors grow their business through sustainable customer acquisition and promotion of the Find Your Limitless paks.

Year 1 \$2,000 Customer Acquisition Bonus:

New Distributors (enrolled on or after January 1, 2018):

Bonus Payment: \$2,000 deposited into a valid ProPay account

Qualification Period: Beginning in a new Distributor's first full commission month, and for 12 consecutive months following.

Example: Distributor A enrolls on 1/28/2018. Their qualification period would begin with their first full commission month in February 2018 – January 2019.

<u>Payout Period</u>: Bonus Payday following completion of their first 12 full commission months in the business.

Example: Distributor A (see above) achieves all requirements through January 2019, and receives their bonus payment of \$2,000 on February 20, 2018.

Requirements:

- Acquire one (1) new Preferred Customer (PC) each month.
- Each PC must maintain a minimum 75 PV LDR order for the qualification period.
- If at any time a PC falls below the 75 PV threshold, the Distributor must replace the PC within the same month.
- At the end of the twelve (12) month period, Distributor will have 12 active 75+ PV Preferred Customers.

Existing Distributors (enrolled before January 1, 2018):

Bonus Payment: \$2,000 deposited into a valid ProPay account

Qualification Period: January 2018 – December 2018

Payout Period: January 20, 2019- bonuses are paid on the 20th of each month for the month prior's commission period.

<u>Starting Point</u>: An existing Distributor's starting point is based on their active 75+PV customer count at the end of December 2017.

Requirements:

- Maintain the starting point number of active 75+ PV customers each month during the qualification period.
- Acquire one (1) new Preferred Customer (PC) each month beginning in February 2018
- Each PC must maintain a minimum 75 PV LDR order for the qualification period.
- If at any time a PC falls below the 75 PV threshold, the Distributor must replace the PC within the same month.

• At the end of the twelve (12) month period, Distributor will have 12 active Preferred Customers beyond their starting point count.

Year 2 \$5,000 Customer Acquisition Bonus:

New Distributors (enrolled on or after January 1, 2018):

Bonus Payment: \$5,000 deposited into a valid ProPay account

Qualification Period: Year two following a Distributor's first 12 full commission months (Months 13-24)

Example: Distributor A enrolls 1/20/2018, February 2018 is considered their first full commission month. Their qualification period for the 2nd Year Bonus is February 2019 – January 2019

<u>Payout Period</u>: The 20th of the month following completion of the bonus requirements.

Example: Distributor A (see above) achieves all requirements in 2019, and receives bonus payment January 2020

Requirements:

- Must have earned the Customer Acquisition Year 1 Bonus
- Generate and Maintain 2,000 PSV (Personal Sales Volume) each month during their qualification period (12 months)
- Enroll and maintain a minimum of 20 active (minimum 75 PV) customers each month during their qualification period (12 months)

Example: Month 13 – 24, a new Distributor must have a minimum of 20 active customers and 2,000 PSV.

Existing Distributors (enrolled prior to January 1, 2018):

Bonus Payment: \$5,000 deposited into a valid ProPay account

Qualification Period: January 2019 – December 2019

<u>Payout Period</u>: January 20, 2020- bonuses are paid on the 20th of each month for the month prior's commission period.

Requirements:

- Must have earned the Customer Acquisition Year 1 Bonus
- Maintain starting PSV (December 2017) AND generate and maintain an additional 2,000 PSV above starting point each month during the qualification period
- Maintain starting active customer count (December 2017) AND enroll and maintain additional 20 active customers above starting count.

Example: December 2017 Starting PSV = 890, Active PC = 8

Year 2 Bonus requirement: Minimum 2,890 PSV and 28 Active PC each month January 2019 – December 2019
