FIT: Fly In Travel Package Promotion

The 2020 FIT promotion is the best way to grow your business and get yourself to each quarterly Limitless Worldwide Fly In event. Distributors can earn access to a VIP event prior to the Fly In (Nights on Broadway) and hotel and airfare. The promotion begins January 1, 2020 through December 31, 2020 and is available to both new and current distributors.

Promotion Period: 1/2020 through 12/2020

Qualification Periods:

May 2020 Fly In (May 15-16): January, February, March, April 2020

September 2020 Fly In (Sept. 18-19): May, June, July, August 2020

January 2021 Fly In (TBD): September, October, November, December 2020

Rewards: Invitation to Nights on Broadway, 2 Night Hotel Stay, Up to \$500 toward airfare.

Requirements: Requirements vary based on the reward, Distributors must earn the rewards in sequence.

Nights on Broadway Requirements:

To earn an invitation for one to the VIP Event: Nights on Broadway (held on Thursday evening of the Fly In), a Distributor must complete the following each month of the qualification period.

- Have any FYL Pak process and ship on LDR (autoship)
- Generate a minimum of 1,000 PSV

Note: A Distributorship can earn 2 invitations to Nights on Broadway by achieving a minimum of 2,000 PSV each month of the qualification period.

<u>Example A:</u> Distributor has Fuel on LDR and 1,000 PSV in the commission months of 5/2020, 6/2020, 7/2020, and 8/2020. This qualifies the Distributor for 1 Invite to the VIP Event, Nights on Broadway.

<u>Example B:</u> Distributor has Shape on LDR and 2,000 PSV in the commission months of 5/2020, 6/2020, 7/2020, and 8/2020. This qualifies the Distributor for 2 Invites to the VIP Event, Nights on Broadway.

2 Nights Hotel Requirements:

To earn a 2-night hotel stay (Thursday and Friday nights) during a Limitless Fly In, a Distributor must earn their invitation to Nights on Broadway (see above) PLUS complete the following each month of the qualification period.

- Help a leg in your Organization achieve a minimum of 1,000 OV for the first time and hold it each month during the qualification period.
- If a qualifying leg fails to meet 1,000 OV in one of the qualifying months, this can be made up in other months during the same qualification period.

<u>Example A:</u> Distributor helps a frontline Distributor achieve 1,000 Organizational Volume for the first time in May 2020. The Distributor maintains that 1,000 OV during the months of June, July, and August 2020. Distributor earns a 2 nights hotel stay.

<u>Example B:</u> Distributor helps a frontline Distributor generate 1,000 Organizational Volume for the first time in May 2020. In June 2020, the leg generates only 500 OV. To make up for June, the Distributor must generate 1250 OV in that leg for the remaining months of the qualification period, July and August 2020.

Up to 500 toward Airfare Requirements:

To earn up to \$500 toward airfare to attend a Limitless Fly In, a Distributor must earn their invitation to Nights on Broadway (see above) PLUS complete the following each month of the qualification period.

- Help 2 legs in your Organization achieve a minimum of 1,000 OV for the first time and hold it each month during the qualification period.
- If a qualifying leg fails to meet 1,000 OV in one of the qualifying months, this can be made up in other months during the same qualification period.

<u>Example A:</u> Distributor helps 2 frontline Distributors achieve 1,000 Organizational Volume for the first time in May 2020. The Distributor maintains both 1,000 OV legs during the months of June, July, and August 2020. Distributor earns both a 2 nights hotel stay, and up to \$500 towards airfare.

<u>Example B:</u> Distributor helps a frontline Distributor generate 1,000 Organizational Volume for the first time in May 2019. In June 2020, 1 of the legs generates only 500 OV, while the other meets its qualification. To make up for June, the Distributor must generate 1250 OV in the that failed to reach 1,000 OV for the remaining months of the qualification period, July and August 2020.

Terms:

Prizes have no cash value or substitutions. A Distributor must attend the Fly In to receive the FIT package rewards. Prizes cannot be transferred without express approval from Limitless Worldwide management.

The Limitless policies and procedures will be enforced for qualification rules, including but not limited to buying-in volume, creating false distributorships (straw-man ID's) in order to fulfill requirements, etc. Additionally, all orders in the downline used to qualify a distributor for any benchmark bonus must be paid for and shipped to the owner of the account. Company reserves the right to disqualify distributors who violate such policies.
