## 2023 Limitless Xperience Incentive

### Official Terms and Conditions

The 2023 “Surf or Turf” Limitless Xperience is designed to recognize and reward Limitless Distributors for business development activities leading to Organizational Volume (OV) growth. Through the promotion **Distributors may earn their vacation or earn credits towards the purchase of their vacation. Alternatively, Distributors may purchase the trip outright.** Airfare can be earned by achieving the top benchmark in the promotion but is otherwise the Distributor and their guest’s responsibility.

**Qualification Period:** April 1, 2022 – April 30, 2023 (13 commission months)

**Eligibility:** Both existing Distributors and Distributors enrolled before February 28, 2023 are eligible to participate.

**Destination:** To be selected by attending Distributors at the end of qualification and confirmation period.

**Limitless Xperience Date:** Fall 2023

**Vacation Value/Purchase Price:** The trip is valued at \$5,000. Credits will be applied to this amount based on OV growth.

**OV and Rank Starting Point:** March 2022

**Qualification Requirements:** Distributors must increase their Organizational Volume by one of the following benchmarks for 2 months during the qualification period.

Additionally, Distributors must meet the corresponding commission rank requirement. Both the OV growth and minimum rank must be held together each month of qualification.

**<sup>§</sup>Credits earned by qualification can only be applied towards the trip, there is no cash payout option.**

**\*\*Earned Trip +Airfare:** Distributors who have achieved the requirements to earn their trip outright will be reimbursed for airfare for two people. Reimbursement will cap at \$500 per ticket.

#### **OV Growth Rules:**

- **<sup>†</sup>2 Month Rule**  
Benchmarks must be achieved for a minimum of two months, however, they do not have to be achieved consecutively. One of the qualifying months must be either March 2023 or April 2023.
- **<sup>‡</sup>50% Rule**  
No more than 50% of the Distributor’s OV can come from any one leg.
- **<sup>‡</sup>Rank Increase Rule**  
Your minimum rank must be at least 1 rank higher than your starting rank (March 2022).

### **Xperience Destination Selection:**

At the close of the qualification period, Distributors attending will select between multiple options provided by the company for the vacation. Votes will be weighed in line with credits earned towards the trip. In the event of a tie for destination selection, the top earner will serve as the tie breaker.

### **Balances Owed:**

After official destination selection is made, Distributors will be sent the updated terms for the incentive trip, along with an invoice for any remaining balanced owed. Balances must be within 30 days of receipt to secure your spot on the trip.

### **Other Terms:**

- The 2023 Surf or Turf Limitless Xperience is limited to a maximum of two participants per Distributorship (One attendee must be listed as a member of the qualifying account).
- Distributors with excessive returns of products in their organization may be disqualified. Limitless Worldwide reserves the right, in its sole discretion, to determine what constitutes excessive returns. If there are any excessive returns in the 12 months following the trip that would have affected paid rank and qualification for the trip, then the Distributor agrees to reimburse Limitless Worldwide for the cost of the trip, and any other recognition at the company's discretion.
