



**Sea your LIMITLESS  
2018 Incentive Cruise**

Get your passports ready and join us as we set sail for Baja Mexico! Rub shoulders with top leaders and friends for three nights and four unforgettable days of comradery, leadership training, and relaxation. The 2018 “Sea your LIMITLESS” incentive cruise is designed to recognize and reward Limitless Distributors for creating and maintaining growth in their business.

**Qualification Period:** (6 commission months) **November 1, 2017 – April 30, 2018**

**Qualification Reward:** Specific dates to be determined for Summer 2018.

**Qualification Requirements:** Distributors must achieve requirements in two categories in order to earn a space on the incentive cruise, Organizational Volume Growth, and Xecutive team strengthening activities.

**1. Organizational Volume Growth:** 12,000 OV (with no more than 50% from any one leg)

**Starting Point:** All Organizational Volume (OV) as of 11:59 pm October 31, 2017.

- **Example A:** OV on October 31<sup>st</sup> is 2,500. This distributor would need to increase their OV to a minimum of 14,500 by the end of the qualification period. Of this 14,500, no more than 6,000 of the growth can come from any one leg.
- **Example B:** OV on October 31<sup>st</sup> is 30,000. This distributor would need to increase their OV to a minimum of 42,000 by the end of the qualification period. Of this 42,000, no more than 6,000 of the growth can come from any one leg.

**2. Xecutive Team Strengthening Activities:** Must achieve one of the following for 5 out of the 6 months of the qualification period.

- Achieve a minimum commission rank of Xecutive3 (X3) and generate a minimum of 500 PSV (personal sales volume)

**Or**

- Generate 1000 PSV (personal sales volume) and promote a new first time front-line Xecutive

**November 2017 “Get Ahead” Promotion:**

Distributors are able to reduce their overall OV requirement based on their November 2017 PSV. Any PSV amount generated beyond 500 PSV for the month of November 2017, will be deducted from their overall OV growth requirement.

- **Example:** A distributor generates 1000 is PSV for the month of November 2017. Due to the November 2017 promotion, they are now able to qualify for the incentive trip with an increase of only 11,500 OV, with no more than 50% coming from any one leg.

**Terms and Conditions:**

1. In order to qualify for the 2018 Incentive Cruise, Distributors must achieve the requirements listed above during the qualification period of November 1, 2017 and April 30, 2018.
2. The Cruise will take place in the Summer of 2018 leaving from Long Beach, California. It is the responsibility of the qualifying Distributor and his/her guest to arrange transportation to and from the departure/arrival port.
3. Limitless Worldwide will pay for one (1) cabin for the qualified Distributor and their guest. Cruise cabin includes port taxes and fees. All additional costs, including gratuities will be the responsibility of the Distributor and his/her guest.
4. The Cruise is limited to a maximum of two participants per Distributorship. This includes partnership agreements with multiple participants named on the account.
5. Cruise participants must have a valid passport prior to departure.
6. Distributors with excessive returns of products in their organization may be disqualified. Limitless Worldwide reserves the right, in its sole discretion, to determine what constitutes excessive returns. If there are excessive returns in the 12 months following the trip that would have affected qualification for the Cruise, then the Distributor agrees to reimburse Limitless Worldwide for the cost of the trip, and any other recognition, at the company's sole discretion.
7. Any indication of manipulation to meet the qualification criteria will disqualify any Distributor attempting to benefit from the manipulation. This includes, but is not limited to, buying in volume for qualification purposes on down line accounts.
8. Limitless Worldwide reserves the right to interpret these Terms and Conditions and any other rules that may affect the 2018 Cruise Incentive.
9. No substitutes or cash equivalents will be awarded. Contests, incentives, or prize items may be included as taxable income on IRS Form 1099. The 2018 Cruise Incentive is non-transferable. Trip cancellation by a Distributor/Registered Guest after official confirmation may incur costs to the Distributorship.
